- EUROPE FINANCE ET INDUSTRIE drove more than 22 % of firms quoted in Paris on the stock market. They were promoted in total for: 10 billion euro
- On a total of more than 300 firms introduced on the stock market by Europe Finance et Industrie
 - 90 are so quoted on Eurolist
 - 126 are so quoted on the Free Market
 - 50 were completely or partly sold of which
 - 14 to 100 % between 50 and 500 M€while
 - 36 sold between 20 and 65 % of their capital for hundreds of M€creating other and new treasures.
 - 10 left the Stock Market
 - 30 went bankrupt, less than 10 % in 30 years from which the owners so saved everything or partly of their heritage.
